Schedule to Conditions of Entry

Eligible entrants	Australian and New Zealand residents who are aged 18 years or older. Directors, management and employees of the Promoter and their immediate family are not permitted to enter. Persons who are banned or excluded from relevant parts of the venue to which the promotion applies or the whole venue are not eligible to enter.
Purchase of Product	Any Food or Beverage items purchased during the Promotion Period receives 1 entry/ticket into the draw.
The Prize	Prize pool is started at \$3000. Each week the jackpot is not won, the prize pool increases by \$250. Maximum Jackpot total is \$16000
Total prize value	Cash Up to \$16,000 per Prize plus consolation prize dinks for non-winning selections.
Total number of prizes	1 Jackpot plus consolation prize dinks for non-winning selections.

Conditions of Entry

Entering the Competing
